



## Solarflare, a Xilinx Company Application Onload Engine, Optical Modules and Breakout Cables Limited 1-Year Hardware Warranty

Before using any of the Products, Purchaser shall determine the suitability of the Products for Purchaser's intended use by considering such factors as overall product design and the processing and environmental conditions to which the Products will be subjected. Solarflare warrants solely to Purchaser, for a period of 1 year from the date a Product is delivered to Purchaser (the "Warranty Period"), that the Product will conform in all material respects to Solarflare's published specifications for such Product in effect as of the date of purchase (the "Limited Warranty"). As Solarflare's sole responsibility and Purchaser's exclusive remedy in the event of any material nonconformity, Solarflare, at its sole discretion, shall repair or replace the Product with the same or equivalent model. The Limited Warranty shall not cover and Solarflare is not responsible for any defects caused by, including, without limitation, misuse, static discharge, lightning, fire, water, earthquake, theft, disappearance, misplacement, abuse, neglect, reckless, willful, or intentional conduct, improper handling, installation, repair, alteration or accident, viruses, or other cause not within the reasonable control of Solarflare, as well as for any minor imperfections in the Product that meet design specifications and imperfections that do not materially alter functionality. The Limited Warranty shall also not cover and Solarflare shall not be responsible for any damage to the Product caused by the combination of the Product with other non-Solarflare products, parts or components. Modification or repair by Purchaser, or at Purchaser's direction, unless specifically authorized by Solarflare, shall invalidate this Limited Warranty.
